Statement of general policy

MMC will seek to prevent accidents and cases of ill-health by managing the health and safety at events and activities they organise.

- Risk assessments will be recorded in writing and will be subject to annual review. Preventative measures will be put in place as necessary.

- Tasks performed by all those involved with MMC to be risk assessed and appropriate instruction provided.
- MMC will engage and consult with members, tutors and volunteers on health and safety conditions.
